47535 State Highway 74, Palm Desert, CA Dr. LeComte-Hinely will speak to us about HARC and how it provides data to support healthy communities in the Coachella Valley in all aspects of health and wellness.



Dr. Jenna LeComte-Hinely, as CEO of HARC, oversees and conducts a wide range of research and evaluation services, including program evaluation, needs assessments, and representative community health assessments.

HARC specializes in providing data that helps improve the social determinants of health. Social determinants of health are the conditions where people live, learn, work, and play.

This includes factors such as the economy, education, social structures and support, neighborhoods and the built environment, and of course, healthcare. A healthy community provides residents with education, jobs that pay a living wage, safe and affordable housing, social support, accessible and affordable healthcare, safety from discrimination and injustice, and much more. Prior to becoming CEO of HARC, Dr. LeComte-Hinely held the role of Director of Research and Evaluation for two years.

Dr. LeComte-Hinely obtained her doctorate from Portland State University in the field of Applied Psychology. Her expertise is in the area of Occupational Health Psychology, which aims to keep workers healthy, happy, and productive. Dr. LeComte-Hinely has been conducting research for more than 18 years, studying a wide range of topics including health, well-being, work-life balance, supportive supervision in the workplace, green business, professional network development, gender discrimination, leadership, and informal science education.

Prior to joining HARC, Dr. LeComte-Hinely worked in the research and evaluation field at the Center for Work-Family Stress, Safety, and Health; the Oregon Museum of Science and Industry (OMSI); and the University of Redlands.

In 2019, Dr. LeComte-Hinely was named one of the top 50 influencers in the Coachella Valley by Palm Springs Life and was included in Desert Charities News' "Women in Philanthropy" issue honoring the industry leaders and influencers. In 2018, Dr. LeComte-Hinely was named one of Palm Springs Life's 40 Under Forty as well as one of Desert Charities Jenna also serves on the Board of Trustees of Borrego Health, one of the largest federally qualified health centers in the United States, and is an affiliated member of the Center for Health Disparities at UC Riverside. She is also an Assistant Adjunct Professor in UC Riverside's School of Medicine with the Division of Clinical Sciences in Social Medicine, Population and Public Health.

Your Tech Trek Selection committee is hard at work ! They have read 22 applications and teacher recommendations, evaluated and scored 3 sections for each student and compiled a scoring grid.

At our long March 8th meeting we discussed each student, gathered scores, and assigned interview teams to visit the schools for interviews with 21 girls. At our next meeting we will face the challenging task of selecting just 10

students for residential TT camp on a college campus and 4 students for virtual TT camp. This is always a difficult meeting as we wish we could sponsor them all!

AAUW California State Public Policy Committee Sets 2023-24 Legislative Agenda by Kathi Harper, State Public Policy Chair

The State Public Policy Committee, in conjunction with our Public Policy Advocate Kathy Von Osten (KVO), has completed their selection of the 30 bills that the committee and KVO will be working on this year. This year our bills fall into the following

categories from the 3 pillars of our Public Policy Priorities:

- 8 "Economic Security" bills
- 11 "Public Education" bills
- 21 "Social Justice" bills
 - 8 "reproductive justice"

- 5 "healthcare"
- 5 "freedom from violence" including sex exploitation, DV, stalking
- 1 "gender-identity protection"
- 2 "voting rights"

The committee then selected our top 3 priority bills, including at least 1 bill which we will co-sponsor ("A" bills). KVO will spend most of her time working on these bills, including working with the authors' offices, attending committing hearings, and writing letters of support. These are also the 3 bills members will advocate for in their Lobby Days visits. We then selected 3 next-level bills ("B" bills), which are important but not as resource intensive. The remaining 24 bills will be handled as "C" level bills. Here is a look at our top 3 bills:

AB1394 – This is our co-sponsored bill. It would allow victims of child sexual exploitation and trafficking to sue a social media platform for between \$1 million and \$5 million if the victim can prove the platform designknowingly, recklessly or negligently facilitated the use of code words for sexual predators to describe the type of child and the type of sexual activity that resulted in the act of exploitation.

SB287 - Would prohibit a social media platform from using a design, algorithm, or feature that the platform knows, or should know, causes child users to: purchase fentanyl; inflict harm on themselves or others; develop an eating disorder or engage in dangerous dieting; purposely take their own lives; and/or experience addiction to the social media platform. A victim of any of these consequences can sue the platform for up to \$250,000 for each violation.

AB549 - Requires all state agencies to conduct an evaluation of all their departments to ensure the state does not discriminate against women, and report their findings every 2 years


